Reminder: MSTARC Retirement Announcement

Dear Clients,

Important Dates:

- **April 1, 2024**: Morningstar Indexes will cease onboarding new indexes to the MSTARC channel. Any new launches will be onboarded to and disseminated by the MSTAR channel.
- **June 1, 2024**: To ensure a smooth transition, we encourage all clients to subscribe to the Cboe Global Indices MSTAR channel by this date.
- **July 1, 2024**: MSTARC index distribution will no longer be available via the MSTARC channel. All index distribution will be moved to the MSTAR channel.

1. What does this mean for clients receiving index data via the MSTARC channel?

If you currently receive data through a third-party data provider and are licensed for the MSTAR channel, no action is required. You will receive all the tickers currently in the MSTARC channel via the MSTAR channel starting July 1, 2024.

If you currently receive data through a third-party data provider and are *not* licensed for the MSTAR channel, please work directly with your provider to be enabled for the MSTAR channel.

If you require uncontrolled distribution of current MSTARC indexes, please see #3 below.

2. Will this migration impact the current index dissemination frequency?

No, all indexes included in this migration will maintain the current dissemination frequency on the MSTAR channel. There are no changes to symbols, calculations or dissemination frequency as part of this migration.

3. How do I access the MSTAR channel via the Choe Global Indices Feed?
